WHEREAS: Article III, Section 7 (c), States the Board shall have the power to, "buy, sell, mortgage, lease, rent, borrow, or do any other act which may alter or change the assets of the Association;..... and

WHEREAS: The present truck is not capable of meeting the demands needed to maintain the grounds, walkways, and parking areas and

WHEREAS: The present finances of the Association do not permit the outright purchase of said vehicle, and

WHEREAS: The adoption of this Resolution will not.. "substantially alter or change the capital structure, or property ownership of the Association..."

Now, therefore, be it Resolved that the Board of Directors apply for and obtain a loan from the Mid-Hudson Federal Credit Union, in the amount of Twenty Five Thousand Dollars (\$25,000.00) for a term not to exceed three (3) years and with an interest rate not to exceed (10%).

And it is further resolved that the Treasurer, George E. Fuhrmann is authorized to execute all documents on behalf of the SunnyBrook Association Inc. in connection therewith.

WHEREAS: Un-collected monthly assessments are rising, creating an undue burden on the Association's finances.

- A late fee of \$25.00 be assessed to any account with any balance (including but not limited to, regular assessment, special assessment, fines or legal fee) remaining unpaid on the fifteenth of each month.
- The Late Fee together with any unpaid balance shall be subject to all
 provisions of Article V Section 6 "Default" of the Association Coverants and
 Restrictions.
